FINANCIALS REPORT: GENERAL FUND \$383,508.96, WW&SS \$307.89, CDBG GRANT \$10,000, SINKING FUND \$41,891.20, WATER TOWER CONSTRUCTION \$35,780.85, FIRE DEPT. \$16,257.05. KELLY DURHAM MOTION AND GALEN OWEN 2ND, WITH A UNANIMOUS DECISION FROM ALL CITY COUNCIL MEMBERS TO APPROVE FINANCIAL REPORTS.

CANVASS OF CITY GENERAL ELECTION FOR MAY 4, 2024. NICK HOLLEY 35 VOTES,

GLORIA GUZMAN 26 VOTES, SARA VUITTONET 62 VOTES, & GLENDA DAVIS 62 VOTES FOR CITY COUNCIL. JOHNNY TAYLOR 65 VOTES, AND EDNA TUCKER 43 VOTES FOR MAYOR. KELLY DURHAM MOTION AND GALEN 2ND, WITH A UNANIMOUS DECISION FROM ALL CITY COUNCIL MEMBERS TO APPROVE THE CANVASS GENERAL ELECTIONS.

ELECTED OFFICIALS WERE SWORN IN BY JUDGE KELLY DUNBAR FOR OATH OF OFFICE, AND FILLINGS OF OFFICE. SARA VUITTONET MOTION AND KELLY DURHAM 2ND, WITH A UNANIMOUS DECISION FOR GALEN OWEN TO CONTINUE AS PRO-TEM FOR THE CITY OF KRESS.

JUDGE KELLY DUNBAR WILL CONTINUE AS KRESS CITY JUDGE FOR MAYOR TAYLORS TERM.


