MEETING WAS CALLED TO ORDER AT 6:00PM BY MAYOR TAYLOR. MOMENT OF SILENCE. DELANE BUSKE MOTION TO APPROVE MINUTES FROM MAY 23, 2022

GALEN OWENS 2ND, WITH A UNANANMOUS DECISION.

MAYOR TAYLOR HAS INFORMATION TO SHARE AND PUBLIC COMMENT AT THE END OF MEETING WITH 5 MINUTE TIME LIMIT (PROFESSIONAL)

TWO SIGNATURES FOR CHECKS MAYOR TAYLOR BEING ONE. DINA VUITTONET MOTION FOR GLENDA DAVIS TO BE THE SECOND PERSON TO SIGN CHECKS.

CODY STURGESS WITH THE FIRE DEPARTMENT WAS CALLED ON HIS CELL PHONE.

CODY STURGESS IS THE ONLY ONE CERTIFIED. IS THERE ANYWAY TO GET TURNED AWAY FROM VOLUNTEERING ON THE FIRE DEPT? BACKGROUND CHECKS ARE DONE. NO ONE HAS BEEN TURNED DOWN IN 2 YEARS. DRAMA & SOCIAL MEDIA CAUSING THE CITY OF KRESS AND THE FIRE DEPT. NOT TO GET ALONG.

CODY STURGESS STATED "NO MATTER WHAT HAPPENS THE FIRE DEPT WILL BE HERE FOR THE CITY OF KRESS."

MAYOR TAYLOR STATED "THAT THE CITY COUNCIL 100% SUPPORTS THE KRESS FIRE DEPT AND COMMUNICATION IS KEY." REQUESTED THE PRESENCE OF CODY STURGES TO THE NEXT CITY COUNCIL MEETING.

GALEN OWENS IS CONCERNED HOW THE FIRE DEPT. SPENDS THEIR MONEY.

GLENDA DAVIS WAS NOMINATED BY MAYOR TAYLOR TO DRAFT CERTIFIED LETTERS TO ALL RANKING OFFICERS OF THE FIRE DEPT. DINA VUITTONET MOTION AND DELANE BUSKE 2ND, WITH A UNANNMOUS DECISION.

FORENSIC AUDIT DEPOSIT FOR THE CITY OF KRESS IS \$10,000. MAYOR TAYLOR DONATED \$5000. FOR FUND RAISER AT KRESS NATIONAL BANK. SARA VUITTONET MOTION AND GALEN OWENS 2ND, WITH A UNANANMOUS DECISION.

MAYOR TAYLOR IS DONATING HIS MONTHLY \$50 CHECK TO THE FORENSIC AUDIT FUND.
