MAYOR TAYLOR CALLED MEETING TO ORDER AT 6:02 PM. MOMENT OF SILENCE WAS CALLED BY MAYOR TAYLOR. COUNCILMAN KELLY DURHAM WAS ABSENT.

PUBLIC COMMENTS: SAM NORIEGA CONCERNED ABOUT HIS WATER BILL.

LUPE REYES CONCERNED ABOUT CITY OF KRESS AUDITS INCLUDING FORENSIC AUDIT.

GALEN OWEN MOTION AND DANE SISEMORE 2ND, WITH A UNANIMOUS DECISION FROM ALL CITY COUNCIL MEMBERS TO APPROVE MINUTES FROM MAY 14, 2024.

FINANCIAL REPORTS: GENERAL FUND \$384,808.53, WW&SS \$1057.58, KFD \$24,969.44. SARA VUITTONET MOTION AND DANE SISEMORE 2ND, WITH A UNANIMOUS DECISION FROM ALL CITY COUNCIL MEMBERS TO APPROVE FINANCIAL REPORTS.

GALEN OWEN MOTION AND SARA VUITTONET 2ND, WITH A UNANIMOUS DECISION FROM ALL CITY COUNCIL MEMBERS TO PURCHASE A JOHN DEERE FC12E FLEX WING ROTARY CUTTER FROM SOUTH PLAINS IMPLEMENT FOR THE AMOUNT OF \$16,605.05.
