GLENDY DAVIS MOTION AND GALEN OWEN 2ND, WITH A UNANIMOUS DECISION FROM ALL CITY COUNCIL MEMBERS TO APPROVE MINUTES FROM AUGUST 15, 2023.

FINANCIAL REPORTS: GENERAL FUND \$282,507.12, WW & SS \$1,676.76, POLICE TRAINING \$3,960.98, SINKING FUND \$22,713.00, WATER TOWER \$19,780.00, KRESS FIRE DEPT. \$17,975.50. DANE SISEMORE MOTION AND GALEN OWEN 2ND, WITH A UNANIMOUS DECISION FROM ALL CITY COUNCIL MEMBERS TO APPROVE FINANCIAL REPORTS.


