DINA VUITTONET MOTION AND DEELANE BUSKE 2ND, WITH A UNANIMOUS DECISION FROM ALL CITY COUNCIL MEMBERS TO APPROVE THE MINUTES FROM OCTOBER 24, 2022

FINANCIAL REPORTS: FIRE DEPARTMENT SEPTEMBER ENDING BALANCE \$20,629.11 & OCTOBER ENDING BALANCE \$23,778.95. GENERAL FUND SEPTEMBER ENDING BALANCE \$203,820.10 & OCTOBER ENDING BALANCE \$196,660.90. WASTE & WATER SEPTEMBER ENDING BALANCE \$18,303.23 & OCTOBER ENDING BALANCE \$13,740.01. CITY OF KRESS WILL SOON HAVE ONLY ONE BANK ACCOUNT COMBINING GENERAL FUND & WASTE & WATER.
